- Encourage a partnership relationship with our Suppliers and Contractors for the delivery of our quality program;
- Provide information to all employees, contractors, suppliers, customers and clients that inform them of quality issues.
- Encourage problem solving throughout all interactions and engagements to ensure we achieve high levels
  of service and implement work practices that continually improve our standards, productivity and
  outcomes for our clients and customers;
- Report and investigate incidents, then improve systems and practices so as to prevent recurrence; and
- Ensure Suppliers and Contractors train their employees to competently work in accordance with relevant procedures and standards.
